

SCHOOL ATTENDANCE AREAS

Background

The Division provides each student with the opportunity to meet the standards of education set by the Minister by effectively utilizing the human and physical resources of the Division. In order to achieve this goal, the Board establishes attendance areas for each school in the Division.

Procedures

- 1. Parents/guardians are expected to register their children at their attendance area school. Principals receiving registration requests from non-attendance parents/guardians are required to direct them back to their attendance area school.
- 2. Attendance areas are established in compliance with Section 121(1) of the Education Act.
 - 2.1. Evansview School
 - 2.1.1. All Kindergarten to Grade 6 students residing within and along the following boundaries:
 - 2.1.1.1. Evansburg north to the Division boundary.
 - 2.1.1.2. Evansburg south to the Division boundary.
 - 2.1.1.3. Evansburg west to the Wildwood School boundary.
 - 2.1.1.4. Evansburg east to the Division boundary.
 - 2.2. Grand Trunk High School
 - 2.2.1. All Grade 7 to Grade 12 students residing in the following areas:
 - 2.2.1.1. Evansburg north to the Division boundary.
 - 2.2.1.2. Evansburg south to the Division boundary.
 - 2.2.1.3. Evansburg west to the west Wildwood School boundary.
 - 2.3. Wildwood School
 - 2.3.1. All Kindergarten to Grade 6 students residing within the Wildwood attendance area.
 - 2.4. Niton Central
 - 2.4.1. All Kindergarten to Grade 9 students residing within and along the following boundaries:
 - 2.4.1.1. Niton north to the Division boundary.
 - 2.4.1.2. Niton south to the Division boundary.
 - 2.4.1.3. Niton east to the Wildwood School boundary.
 - 2.4.1.4. Niton west to the Fulham Elementary School boundary.
 - 2.4.1.5. Niton west to the Mary Bergeron Elementary School boundary.

- 2.5. Fulham School
 - 2.5.1. All Kindergarten to Grade 6 students residing within the Fulham area.
- 2.6. Mary Bergeron Elementary
 - 2.6.1. In the town of Edson All Kindergarten to Grade 5 students that reside:
 - 2.6.1.1. On the East side of 51 Street and East of 51 Street;
 - 2.6.1.2. East of Edson Drive; and
 - 2.6.1.3. East of Highway 748.
 - 2.6.2. Rural Edson All Kindergarten to Grade 5 students that reside:
 - 2.6.2.1. North of Edson and East of Highway 748, to the Division boundary:
 - 2.6.2.2. On both sides of Golf Course Road (Rge Rd 172) including Spruce Street; and south to the Division boundary;
 - 2.6.2.3. East of Edson, to the boundaries of Fulham and Niton.
- 2.7. École Westhaven Elementary
 - 2.7.1. In the town of Edson and Rural Edson Area **All Kindergarten to Grade 5** French Immersion (FRIM) students.
 - 2.7.2. In the town of Edson All Kindergarten to Grade 5 students that reside:
 - 2.7.2.1. On the West side of 51 Street, and to the West of 51 Street;
 - 2.7.2.2. West of Edson Drive; and
 - 2.7.2.3. West of Highway 748.
 - 2.7.3. North of the Town of Edson and West of Highway 748;
 - 2.7.3.1. South-west of the Town of Edson, (excluding Golf Course Road) to the Division boundary;
 - 2.7.3.2. West of the Town of Edson to the boundary of the Hinton Zone
- 2.8. École Pine Grove School
 - 2.8.1. All Grade 6 to Grade 8 English students in the Edson area.
 - 2.8.2. All Grade 6 to Grade 8 French Immersion students in the Edson area.
 - 2.8.3. All Grade 7 and Grade 8 students residing in the Fulham attendance area.
- 2.9. Parkland Composite High School
 - 2.9.1. All Grade 9 to Grade 12 students residing in the following attendance areas:
 - 2.9.1.1. Fulham School attendance area
 - 2.9.1.2. École Pine Grove School attendance area
 - 2.9.2. All Grade 10 to Grade 12 students residing in the Niton attendance area

2.10. Crescent Valley School

- 2.10.1. All Kindergarten to Grade 7 students residing within the following Hinton neighbourhoods and to the following boundaries (excluding French Immersion students):
 - 2.10.1.1. Hardisty
 - 2.10.1.2. Thompson Lake
 - 2.10.1.3. Eaton
 - 2.10.1.4. West Riverside
 - 2.10.1.5. Riverside
 - 2.10.1.6. All out-of-town students residing to the east of the Hinton town boundaries to the boundary of the Edson zone.

2.11. École Mountain View School

- 2.11.1. In the Town of Hinton and Hinton Area **All Kindergarten to Grade 7** French Immersion (FRIM) students.
- 2.11.2. All Kindergarten to Grade 7 students residing within these Hinton neighbourhoods and boundaries:
 - 2.11.2.1. Hillcrest
 - 2.11.2.2. Mountain View
 - 2.11.2.3. Terrace Heights
 - 2.11.2.4. All out-of-town students residing to the west of the Town of Hinton boundaries to the boundary of the Hinton Zone.
- 2.12. Harry Collinge High School
 - 2.12.1. All Grade 8 to Grade 12 students, English and French Immersion, residing within the following areas:
 - 2.12.1.1. Crescent Valley school attendance area
 - 2.12.1.2. École Mountain View school attendance area
- 2.13. Jasper Elementary School
 - 2.13.1. All Kindergarten to Grade 6 students residing in and around the Town of Jasper.
- 2.14. Jasper Junior Senior High School
 - 2.14.1. All Grade 7 to Grade 12 students residing in and around the Town of Jasper.
- 2.15. Sheldon Coates School
 - 2.15.1. All Kindergarten to Grade 3 students residing in and around the Town of Grande Cache.
- 2.16. Summitview School
 - 2.16.1. All Grades 4 to Grade 8 students and early intervention students residing in and around the Town of Grande Cache.
- 2.17. Grande Cache Community High School

- 2.17.1. All Grades 9 to Grade 12 students residing in and around the Town of Grande Cache.
- 3. Out-of-boundary attendance is permitted within defined constraints:
 - 3.1. Principals will ensure that all students residing within the attendance area defined for the school are accommodated before accepting students from outside the school attendance area, as per Section 10(3) of the Education Act
