- Hosted the Principal Division Leadership Team Meeting and discussed instructional rounds, protocol guiding the principals and their staff.
- Hosted the Board Planning Seminar which included a financial overview for the Board, and discussed the role of governance with a review of the book, The Governance Core.
- Participated on a teleconference call with the Deputy Minister of Education, and discussed financial concerns over the substantial insurance premium rate increases.

Alberta Education Budget and Business Plan

 On October 24, 2019, the Province of Alberta announced the provincial budget with a new funding and assurance model as part of Budget 2020. Trustees received an update from S. Nicholson, Secretary Treasurer, on the anticipated financial impacts to the Division. As the 2019/2020 is a transition year between the current kindergarten to Grade 12 Funding Framework and the new funding model, the Division does not expect to realize the complete affects until the complete provincial budget is announced in February 2020.

Ministerial Order #042/2019 – Seclusion and Physical Restraints in Alberta Schools Standards

 Trustees were provided an update on the Order which comes into effect as of November 1, 2019. The report included the Division's recent steps to align with the new guidelines and the public information resources being developed.

Teacher Mentorship

 Since 2016, the Division's Teacher Mentorship Program has provided valuable support to new teachers and teachers new to the Division with a designated mentorship lead teacher who uses strategies such as collegial support, collaborative learning, and reflective teaching practices that focus on the Teaching Quality Standard.

Mary Bergeron Elementary School Crosswalk Lights

 As part of the final construction phase, crosswalk lights were installed on October 30, 2019, at Mary Bergeron Elementary School in Edson, Alberta. GYPSD facility staff and staff from the Town of Edson observed traffic flow
